- Article 1: To elect a Moderator by written ballot to preside at said meeting.
- Article 2: To elect a Selectman, Assessor and Overseer of the Poor by written ballot for a threeyear term starting July 1, 2025.

Revenue Budget Article

Article 20: To see what sum of money the Town will vote to raise and appropriate from the Non-Property Tax Revenue Budget for the articles approved in Article 5 through Article 19 inclusive and the remainder to be raised by property taxation.

Recommendation: Amount recommended to pass.

\$ 516,871.00 to be appropriated from Non- Property Tax Revenue Budget; and the remainder to be raised by property taxation.

Ordinance Articles

Article 21: Shall the Town vote to enact the Town of Greenwood Noise Ordinance.

This is a citizen initiative.

Estimated cost of equipment and training - \$ 5,000.00

Unknown amount for payroll costs as it is unknown how many complaints the Codes Enforcement Officer will be responding to annually.

Article 22: Shall the Town vote to enact the proposed amendments to the Town of Greenwood Land Use Ordinance - Sec. 4. Permit, A. Setbacks – amendments in red lettering below.

This is a citizen initiative.

A. Set Backs

All structures on right of ways of less than 33 feet will be set back at least 25 feet from the center of the right of way. All structures on right of ways of 33 feet or more will be 50 feet from the center of the right of way.

The front setback will not apply to existing lots for additions to existing buildings or accessory buildings such as garages. In these instances, the new construction is allowed provided the nonconformance is not greater than the existing neighboring buildings on the street or road as determined by the Code Enforcement Officer's /Planning Board measurements.

The minimum distance from side and rear lot lines to a new residential structure is $\frac{10}{25}$ feet. If, prior to acceptance of the 2510 -foot rule, a structure was within the 10 feet of a lot line, a structure can be rebuilt in the exact same space. The minimum distance from side and rear lot lines to a new commercial structure is 50 feet. All lots shall be able to accommodate a circle having a diameter of 150 feet.

Business Articles

Article 23: To see if the Town will vote to set dates when taxes on Real Estate and Personal Property shall be due and payable and after which interest shall accrue.

Recommendation: Two Installments/Payments

First installment due, Tuesday, October 1, 2025, with interest starting on Monday, November 3, 2025.

Second installment due, Friday, April 1, 2026, with interest starting on Monday, May 1, 2026.

Article 24: To see if the Town will set a rate of interest to be paid after the due dates on delinquent taxes.

Recommendation: Interest rate: **7.5%** - The maximum allowed by Henry Beck, Treasurer of State (Title 36, M.R.S.A. Section 505.4)

Article 25: To see if the Town will set a rate of interest to be paid by the Town on abated taxes at 7.5% pursuant to (Title 36, M.R.S.A. Section 505.4)

Recommendation: Selectmen recommend the article to pass.

Article 26: To see if the Town will vote to authorize the Tax Collector to accept tax payments prior to the commitment of taxes.

Recommendation: Selectmen recommend the article to pass.

Article 27: Shall the Town vote to authorize the Selectmen to sell by bid/bidding real estate acquired for non-payment as they deem advisable for the best interest of the town. Sale to be advertised once per week for two consecutive weeks in the two newspapers of local circulation. The Selectmen may without auction or advertisement sell to the person or persons to whom a property was taxed at the time the property was acquired by the town, or to their heirs or assigns, such property for the amount of the accrued taxes, interest and costs within twelve months after foreclosure and shall deliver a municipal quit claim deed for such properties. Also, to authorize the Selectmen to keep any part or parcel thereof for municipal purposes and use.

Recommendation: Selectmen recommend the article to pass.

Article 28: To see if the Town will authorize the Selectmen and Treasurer, on behalf of the Town to sell or dispose of Town property, obsolete Town equipment and material on such terms as they deem proper.

Recommendation: Selectmen recommend the article to pass.

Article 29: To see if the Town will authorize the Board of Selectmen and Treasurer to enter into multiyear contracts necessary to provide services to the Town.

Recommendation: Selectmen recommend the article to pass. Services for the Town include but are not limited to assessing, ambulance service, banking, and rubbish removal.

Article 30: To see if the Town will authorize the Selectmen to accept on behalf of the Town, monetary gifts, and to appropriate said gifts to supplement the accounts specified by the benefactor.

Recommendation: Selectmen recommend the article to pass.

Article 31: To see if the Town will vote to authorize the Municipal Officers to make final determinations regarding the closing or opening of roads to winter maintenance pursuant to Title 23 M.R.S.A Section 2953.

Recommendation: Selectmen recommend the article to pass.

Article 32: To see if the Town will vote to authorize the Municipal Officers to make applications for, accept and expend on behalf of the Town of Greenwood all gifts, grants, or other funds as may now hereafter be available or forthcoming.

Recommendation: Selectmen recommend the article to pass.
